Thereafter, the Technical Evaluation Committee has evaluated all 6 (six) bids and prepared evaluation sheet containing all information in respect of bids.
4. On the basis of evaluation of the documents of technical bids by the technical evaluation committee. The technical evaluation committee decided to recommend the successful bidders. Accordingly, based upon the qualification criteria mentioned in RFP, the tender committee declares following bidders as technically responsive, as mentioned below:-




